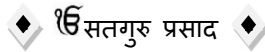

- Master's Degree in Law (LL.M.) with at least 55% marks (50% for SC/ST candidates).
- Ph.D. in Law from a recognized university.

##### 2. Experience

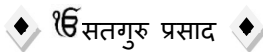
- Minimum 15 years of teaching and/or research experience in Law at universities, colleges, or other higher education institutions.
- At least 5 years of teaching experience at the postgraduate level (LL.M.) as required under Statute 28, Part VI – 16(3)(A)(c)(i).
- At least 3 years of experience in guiding research, as per Statute 28, Part VI – 16(3)(A)(c)(ii).
- A minimum of 10 research publications in peer-reviewed or UGC-listed journals.
- A minimum Research Score of 110, as per Appendix II, Table 2 of the UGC Regulations, 2018.

##### 3. Other Requirements

- Demonstrated academic leadership and administrative experience.
- Significant contributions to legal research and publications shall be an added advantage.

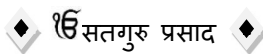

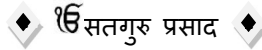
